POSITION OVERVIEW

The Attending Physician role is within the Community, Hospice, and Long-Term Care division of Kensington Health. This role reports to the Medical Director Long-Term Care and is accountable for providing medical care to a roster of people living in Kensington Gardens.

Kensington Gardens is a 350-person long-term care home located in the heart of the Kensington community in downtown Toronto. Kensington Gardens supports individuals who require long-term care by providing comprehensive and holistic interdisciplinary care.

RESPONSIBILITIES

1. Provide services to meet the medical needs of residents in the assigned Resident Home Area(s), at the LTC Home, including assessment, planning, , and provision of individualized medical care, consistent with professional standards of care, and obtaining informed consent for individual treatment(s) and the treatment plan.
2. Conduct weekly physician rounds according to an approved schedule.
3. Be a member of and attend the Professional Advisory Committee.
4. Supervise students and residents during the provision of services hereunder, including medical students, postgraduate resident trainees and other learners as agreed upon.
5. Participate in 24-hour on-call medical coverage for those living in the LTC Home.
6. Support and participate in LTC Home-wide issues, such as infectious disease outbreak management.
7. Be available to receive reports on medication safety incidents and adverse drug reactions regarding residents with whom the Attending Physician is involved and provide corrective action or other medical services in response to same.
8. Collaborate with the interdisciplinary care team members of the LTC Home, as needed, to make arrangements for residents whose care needs can no longer be met at the LTC Home to be admitted to a hospital or other facility best suited to provide required care at the earliest possible opportunity and document the order for transfer/discharge on the medical record of the resident.
9. Complete all forms pertaining to the medical care of residents as required by applicable legislation and regulations. The completion of all said forms shall be without direct cost to the resident, family, or LTC Home; forms related to services not insured by the Ontario Health Insurance Plan (OHIP) or services not required by legislation may be billed directly to the resident or Substitute Decision Maker, if applicable.

QUALIFICATIONS

- Minimum qualifications Medical Doctor degree from a recognized educational institution
- Current licensure with good standing with the College of Physicians and Surgeons of Ontario
- Minimum two (2) years experience working in a long-term care setting; minimum of five years in clinical practice
- Experience in supporting quality improvement initiatives and research preferred.
- Proficiency in documenting resident interactions in Point Click Care and maintaining confidentiality in accordance with PHIPA regulations.
- Proficiency with Microsoft Office

- Strong communication and interpersonal skills for collaborating with interdisciplinary teams, residents, families, and caregivers.
- Ability to work independently and as a team member.
- Committed to continuous education and learning of self and others.
- Demonstrated good attendance and performance records with the ability to maintain these same standards.
